2019 Statistics – Notes

CAA finished 2019 on a very positive note. Our overall save rate has increased from 72% in 2018 to 77% in 2019. There are many factors contributing to that success.

The save rate for dogs went from 68% to 73%. Intake was down. Adoptions, rescue/transfers and Return To Owner varied, but Dogs in Foster increased from 486 in 2018 to 885 in 2019 (+82%). Fostering shelter pets saves lives! We could not do what we do without our foster families.

The cat save rate went from 78% to 80% with remarkable results in several line items. While cat intake went up 17% (3154 in 2019 vs. 2700 in 2018), cat adoptions increased by 80% and cats in foster by 150%. Our positive outcomes for cats were so strong that we were able to take in 36 cats during the 4th quarter from other shelters needing help (number included in Strays). It gives our team great satisfaction to be able to lend a hand to nearby shelters in need. We certainly know what it's like to be beyond capacity!

Otherwise, the increased cat intake is made up largely of neonates and kittens under 7 weeks old. This category jumped significantly from 2018 to 2019, possibly because community awareness of CAA has grown, the new shelter is more inviting and it is more conveniently located.

To reduce cat intake, we remain committed to bringing the Stray and Animal Control intake numbers down through TNR. 1083 cats were impounded for TNR and 1179 were TNR'd without impounding in 2019. This is a grant-funded community service. We thank the Feral Cat Coalition for working with us towards this goal and the ongoing rotations of LSU vet students who get hands-on experience at the operating table.

On cat outcomes, shelter management attributes the increased adoptions (+433) and fosters (+410) to the new shelter and to dedicated volunteers who focus entirely on cats, advocate for them, foster them, and spend entire days at the shelter several times a week. Again, fostering saves lives and we could not do what we do without our foster families nor without our volunteers.

Pets for Life: This grant-funded program continues to establish trust in the 70805, 70802 and 70807 communities by providing help to families who may not have the ability to care for their four-legged family members. Many of the animals CAA takes in come from these areas. It is our goal to reduce their number. A total of 515 new pets were met in 2019. In addition to valuable information, we provided 861 medications and services (flea preventative, dewormer, nail trimming and more), 143 supplies (leashes, collars, food), and 219 dogs were spay/ neutered. This is grass roots, word of mouth, animal welfare activism at its best. Our PFL staff member has created relationships. Neighbors tell neighbors to welcome us. CAA is making a difference.

As always, the Other category in 2019 included pigs, goats, cows, horses, snakes, birds, rabbits and more. (See our Facebook page!) For those animals which are not returned to their owner or adopted, CAA has good relations with rescue groups for almost everything.
